7. Staff Reports:

SEAC: November 2022 Administration Report

We are looking forward to recognizing Classroom Support Staff Appreciation Day next Wednesday, November 16 across the DDSB. Classroom Support Staff includes individuals in professional roles working alongside students in their well-being, learning and connections. Roles include ASL Interpreters, and Developmental Support Workers, Educational Assistants, Intervenors, and Language Acquisition Support Worker. We are looking forward to highlighting the incredible work of these team members through social media and through the activities engaged across individual schools in recognition of team members.

Next Friday, individuals in these same roles will engage in a day of professional learning. The DDSB is committed to addressing barriers that affect students' well-being, learning and success. An inclusive model of special education identifies, prevents and addresses barriers that may affect students' well-being and ability to learn. It is through knowledge building and an examination of our practices that we will ensure that we better serve all our learners and support staff. Supported by teams from across Inclusive Student Services, learning opportunities include topics such as, but not limited to, Behaviour Management Systems training, Inclusive Technology, Mental Health & Justice, Tier One Mental Health & Well-Being, Engaging Early Communicators Through Play, Augmentative Communication and Language Modelling and much more. We thank community partners such as Grandview and Lake Ridge Community Support Services for providing teams to facilitate sessions on: An Overview of the Ontario Autism Program - Early Transition to School program, Lift and Transfer Training. A listing of courses will be shared with SEAC.

We are at the point in the school year where we begin planning for 2023-2024. Schools are preparing for the administration of the CCAT (Canadian Cognitive Abilities Test), group testing, as part of Gifted screening. This fall, just over 2200 students, mostly in Grade three, will take part through self-nomination.

Please stay tuned for the announcement of an Additional Qualifications Course subsidy for special education related teacher courses. An emphasis is on courses including: Equitable & Inclusive Education, Hearing, Deaf, Deaf/Blind, Vision qualifications and Special Education Parts 1, 2 and Specialist. The information flier, to be distributed shortly throughout the DDSB, will be shared in the December SEAC package.

This concludes our Administrator report for November 2022.

Board: Trustee Christine Thatcher informed SEAC members that the Board of Trustees is delighted to welcome new Director Camille Williams-Taylor. Camille was with our board for several years as Superintendent and has a strong focus on equity inclusion and diversity, collaboration and teamwork. The Board of Trustees also received information and presentations on: the consolidated School Community Council (SCC) and Parent Involvement Committee (PIC) document. Ontario Public School Board Association (OPSBA) will be holding an advocacy day on November 28 where Trustees will have an opportunity to speak with local MPPs and bring forward any concerns. Classroom Support Staff Appreciation Day – November 16

Professionals in classroom support staff roles are critical in the support of student well-being and learning.

Roles include:

- ASL Interpreter
- Developmental Support Worker
- Educational Assistant
- Intervenor
- Language Acquisition Worker

We would like to recognize the health role that nurses support in schools through community partnerships and health funding.

Professional Learning: Acceptance & Commitment Therapy

- Staff members from Social Work and Psychological Services participated in training: Acceptance and Commitment Therapy (ACT)
- ACT is a therapeutic approach included in what is often known as the 'third wave' of therapies
- ACT develops psychological flexibility and is a form of behavioral therapy that combines mindfulness skills with the practice of self-acceptance
- In total, 35 staff members participated in the training that was offered on a live webinar group format as well as an individual learn-at-own pace format

New to DDSB: Educational Assistant Supply Orientation

The Durham DSB continues to hire professionals into the role of Education Assistant – Supply. On October 24th, 51 new to DDSB staff in this employee group participated in a full day orientation and on-boarding training.

The day was supported in collaboration between: CUPE, Health & Safety, Inclusive Student Services, Innovative Technology and Recruitment.

- Employment goals tool and format

- Superintendent Andrea McAuley suggested having members of the DDSB Planning team attend a SEAC meeting to share feedback and accommodations for new builds
- K-12 building standards existing AODA building code is not reflective
- Less costly to add accessibility from the beginning than to retrofit already existing buildings
- Audits may need to be done on older buildings
- Every new school is opening with a clinical space, and two purpose built special education classrooms with additional spaces within each classroom to allow for ease of integration

14. Community Concerns:

Concerns around the bus driver shortage, there are issues with equity and access to buses.

- The bus driver shortage is a province wide issue
- Student learning is disrupted
- Bell times did help to accommodate some of the issues, however the significant enrolment increase has caused greater strain
- Conversation with Durham Region Transit has been on going about reinstating some routes that have been removed during COVID and now re-establishing these routes with discounted rates in the works

Concerns around schools that run dual track programs

- Disproportionate class sizes
- Whitby found that 1/3 English to 2/3 French Immersion prior to COVID and since then we have seen a shift to more 50/50
- Southwood Park P.S. is more of a 20/80 split
- Boundary planning is often met with resistance

- Concerns around supporting within a small cohort
- Look at support for students in the French Immersion
- Perhaps kids are being withdrawn from French Immersion because they may not be receiving supports in French
- Look at the whole dual track school system and compare how many have identifications
